## WHAT IS THIS TRAINEESHIP ABOUT?

**TLI31716 - Certificate III in Mobile Crane Operations** is designed for mobile crane operation within the Transport and Logistics Industry and other industries. It involves a broad range of skilled applications applied in a wide variety of contexts. Successful achievement of the high risk work (HRW) and heavy vehicle licensing units in the qualification must align with applicable licensing and regulatory requirements.

To obtain this qualification you will require:

- ❖ 12 core units of competency
- ❖ 5 elective units (3 elective may be substituted from a relevant endorsed Training Package)
