WHAT IS THIS TRAINEESHIP ABOUT?

RII30915 - Certificate III in Civil Construction (Bridge Construction and Maintenance Stream) is designed for persons working in civil construction and can be tailored to meet the needs of those working in specialist occupation of Bridge Construction and Maintenance.

To obtain this **Bridge Construction and Maintenance Stream** qualification you will require:

- ❖ 7 core units of competency
- ❖ 18 elective units (5 electives may be substituted from a relevant endorsed Training Package)

HOW IS THE COURSE MADE AVAILABLE?

This course is available to be delivered by Australian Training Management Pty Ltd as a registered traineeship qualification enrolled by a corporate employer.

Traineeship Pathways

Persons who are employed either full time or on a permanent part-time basis for a minimum of 20 hours per week can apply for this traineeship.

Available Funding and Incentives

Funding is available under the state based User Choice program. To take advantage of this funding employers should enrol new employees who have been employed for not more than 3 months under User Choice. Employees who have been employed for more than 3 months are classified as 'existing workers'. Employers can receive payroll tax exemptions for eligible new employee trainees.

Recognition of Prior Learning and Mutual Recognition

Recognition of Prior Learning (RPL) is also available to all trainees. RPL recognises skills and competency developed through work and life experiences. In addition to RPL, Australian Training Management Pty Ltd recognises the AQF Qualifications and/ or Statements of Attainment issued by any other Registered Training Organisation.
