



Supervise Asbestos Removal incl. Remove Non-Friable Asbestos

Course Code ATM014

AIM OF THE COURSE / TARGET GROUP

This course prepares participants for the Supervision of Asbestos Removal and the removal of asbestos containing material, by providing individuals with the necessary skills and knowledge to enable them to safely plan for, prepare a site, supervise personnel in the removal of asbestos containing material, contain, and carry out work involving non-friable (bonded) asbestos-containing material. This course is suitable for individuals working as the Supervisor of asbestos removalists, in the telecommunications, NBN, construction, demolition, trenching, fencing and similarly related industries. This course is suitable for persons removing more than 10 square metres of bonded asbestos in a workplace.

DURATION

8 hours *Please note: The course may be completed within a shorter or longer time frame depending on the experience of those in attendance*

COURSE CONTENT

This course is based on the requirements outlined in the Regulations, Code of Practice, National Standards and includes:

- Legislative framework
- Types, uses and sizes of asbestos
- Plan for, prepare and isolate a site for the removal of asbestos
- Procedures for removal and disposal of non-friable (bonded) asbestos
- Personal Protective Equipment (PPE) for non-friable (bonded) asbestos removal
- Supervise the asbestos removalist and licensed asbestos assessor
- Oversee the asbestos removal and decontamination process
- Carry out the asbestos removal, containment and decontamination process
- Supervise and support team members
- Risk management and equipment testing
- Preparing a Safe Work Method Statement and an Asbestos Removal Control Plan
- Procedures for removal and disposal of non-friable (bonded) asbestos

ASSESSMENT METHOD

Knowledge based questionnaires and observation of practical demonstration

PRE-REQUISITE FOR THIS COURSE

- Must have basic English literacy skills, the Construction Industry Whitecard (CPCCOHS1001A Work safely in the construction industry)
